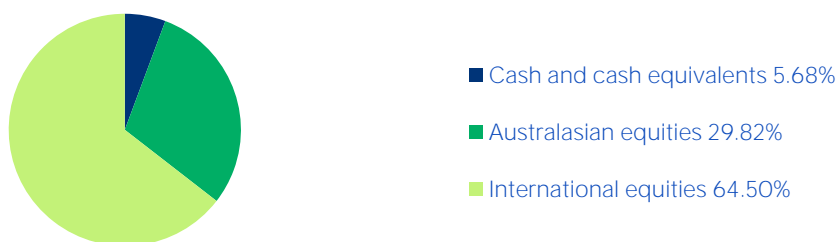

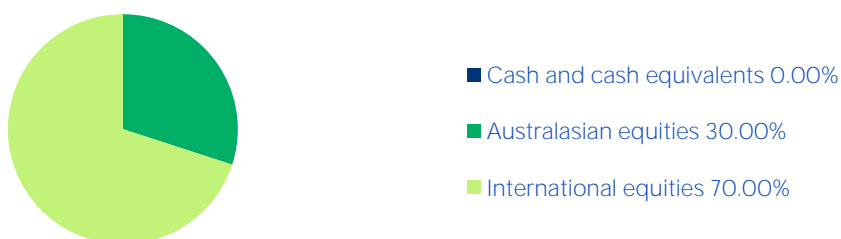

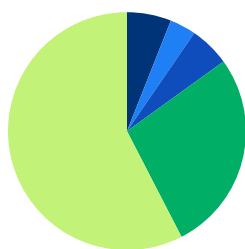

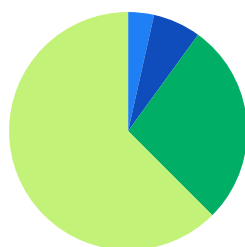
Actual investment mix

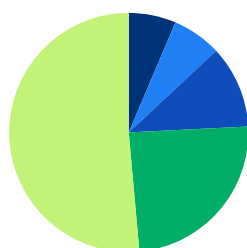

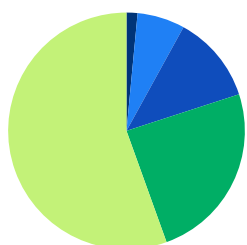

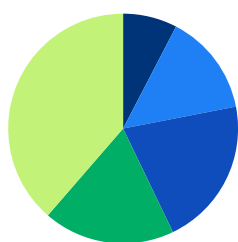

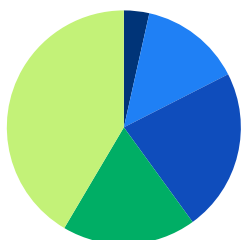

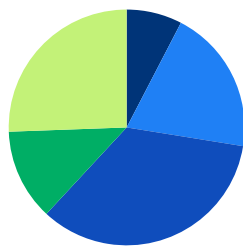

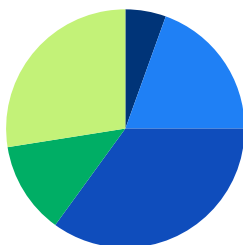
Actual investment mix

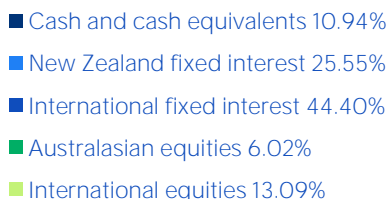

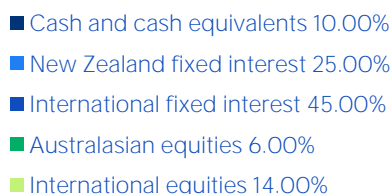
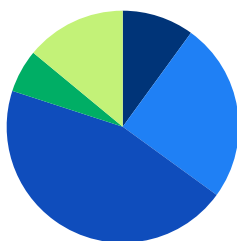
This shows the types of assets that the fund invests in.

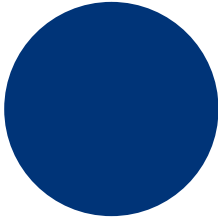

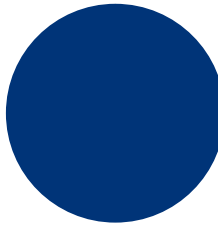
Actual investment mix
